1. Election Process

In British Youth Council elections we use Single Transferable Vote (STV). This year we will be using ElectionBuddy for our policy votes and for our election process. Each voting delegate will put numbers next to candidates, with their favourite candidate as number one, their second favourite as number two, and so on. Voters can put numbers next to as many or as few candidates as they like. To get elected, candidates need to reach a set share of the vote, known as the quota, determined by the number of positions to be filled and the number of eligible votes.

Each voter gets just one vote, but the numbering provides instructions for the counters to allow the vote to transfer. Once all the votes are counted, any candidates who have more than the quota are elected. In order to properly represent the view of the electorate, rather than waste votes over the quota, these votes are re-distributed based on the voter's instructions. If no candidate gets elected then the worst performing candidate is eliminated and their votes redistributed. This process continues until all seats are filled.

Along with the candidates, in each election there will be an option to select 'Re Open Nominations (RON)'. 'RON' is a democratic mechanism to allow voters to choose not to elect any of the candidates in the election. If RON wins the election, then nominations will re-open and this will give more people the chance to stand for the position.

You should vote RON if you feel that none of the candidates are up to the job. However if you think that only one candidate is worth your vote, then you may choose to vote RON as your second choice. If there are two candidates that are worth your vote then you may choose to vote RON for the third choice, and so on. You do not have to vote for RON at all if you don't want to.

At the Annual Council meeting we will be electing:

- One Chair
- Two trustees (top two candidates)
- One UK Young Ambassador for the European Youth Forum
- One UK Young Ambassador for the Commonwealth Youth Council



2. Trustee and Chair Elections

Duties of the Trustee Board are defined by Memorandum and Articles of Association, and by the Rule Book of the British Youth Council. The Board is responsible for strategic planning, accountability and measurement of performance of the British Youth Council as a whole. This requires Board members to collectively have a wide range of skills, knowledge and experience.

These areas include:

- Governance:
- Financial knowledge and expertise;
- Fundraising and income generation;
- Developing external partnerships;
- Strategic planning and leadership;

- Advocacy;
- Marketing and brand promotion;
- Knowledge of youth participation;
- Human resource management.

The British Youth Council is particularly seeking a diverse range of Board members (in terms of experience, skills and background) to continue delivering good governance and take forward our strategy.

It is important that candidates are able to adopt a UK-wide perspective on issues that will be addressed by the Board, and the ability to step beyond any member organisation that they may have come from. It is also important that Board members do not hold significant posts in Member Organisations or British Youth Council programmes, once appointed, both to ensure that there is no conflict of interest, and also to ensure that they are able to devote the time required to their role.

Nominations for the roles of Chair and Trustee were reviewed by a sub-group of the Board of Trustees, and the long-listed candidates were invited to interview. The short list that is being presented to the Annual Council Meeting consists of those candidates who met the minimum requirements, and the sub-group is happy to recommend that any of these candidates become members of the Board.

At the Annual Council Meeting, two new trustees and one Chair will be elected by delegates of full member organisations. Trustees will serve for a term of three years and the Chair will serve for a term of two years.



3. Role of a Trustee

The Board of Trustees are legally responsible for the charity – this is a significant responsibility and one that should not be taken lightly. They have responsibility for ensuring it is well run, is financially secure, and doing the work it is meant to be doing. All those elected to the Board will serve as Trustees, and so will share the Board's responsibilities.

General duties of a Board (Charity Commission):

- Ensure the charity is carrying out its purposes for the public benefit;
- Comply with the charity's governing document and the law;
- Act in the charity's best interests;
- Ensure the charity is accountable;
- Manage the charity's resources responsibly;
- Act with reasonable care and skill.

As well as the legal duties and those detailed in the Charity Commission guidance, the British Youth Council defines the responsibilities of the Board in its rule book and these can be summarised as:

- to set the vision, values and objectives of the organisation;
- to develop the strategic direction of the organisation, sometimes using subcommittees to do this work;
- to act on behalf of the British Youth Council as a decision making body on some policy matters as set in Council Meetings;
- to appoint from its members and from member organisations, representatives as necessary;
- to represent the Council to other bodies, and allocate representation opportunities to the most appropriate committees;
- to be responsible for all financial and legal aspects of the organisation, including buildings, property and assets of the British Youth Council;
- to promote the British Youth Council to external organisations, and review and develop partnerships;
- to be responsible for the appraisal of their own work;

Trustees act collectively as part of the Board of Trustees. Together, the Board is responsible for all of the points above.

In addition to the role outlined above, the Chair has the following responsibilities:

- to chair meetings of the Board of Trustees and to lead their work;
- to act as the line manager of the Chief Executive;
- to seek external advice for the Board where necessary;
- to lead the review of the Board's performance;
- to lead the Board in its accountability to members and stakeholders for the performance of the charity.

4. Candidates for Chair

Candidate 1: Joshua Garfield

Young people are heading for our most challenging moment in living memory. After a decade of struggle, we risk paying the biggest prices for the UK's darkest hour. Making study choices with delayed results. Worrying for the health of our most vulnerable loved ones. Graduating into an economy with fewer opportunities than ever before. And being asked to pay the price for the government's economic recovery programme. Young people will be left at the back of the queue if we do not channel our collective

I am passionate about ensuring young people are well heard, represented, and served by BYC through the next chapter of its governance. As chair, I will ensure our representative member organisations throughout the nations and regions are at the decision-making tables that affect their lives. If elected chair, I will use my political knowledge and skills to guarantee BYC's future through its fundamental role to the success of young people across the UK

Candidate 2: Osaro Otobo

My name is Osaro, I'm from East London, and I completed two degrees at the University of Hull. As a first-generation Black British woman growing up in a non-political household, I discovered later on the importance of equipping young people to make social and political change. I want to be your new Chair because I am determined to make sure young people know their value and can shape their own futures.



In a global pandemic and post-Brexit world, young people are concerned more than ever about a range of important issues including the climate crisis, education, mental health and unemployment. We must be heard. My priorities are:

- 1. Lobbying the UK government to create a plan to support young people through the pandemic and its long-term consequences.
- 2. Improving membership communication, engagement, retention and recruitment.
- 3. Ensuring BYC is financially sustainable through this pandemic and beyond.

I am proud to have been a leader of membership organisations at local, national and international level, through education and sport. I was elected Youth Sports Trust Young Ambassador of the London Borough of Redbridge. I was elected for 3 successive years as a trustee and then two-term President of Hull University Students' Union, where I was the first female Black President. I was a member of the England Women's basketball team and involved with our national and international governing bodies.

Over the last year, I created the #makediversitycount campaign to amend the Equality Act to make it a legal requirement for organisations to have a robust anti-discrimination policy, which gained national media coverage.

I believe the unique combination of my experiences and my passion will help BYC continue to become more relevant and inclusive. I would be honoured to be Chair for a charity that champions the voices of young people.

Candidate 2: Sarah Staples

We know this is a difficult time for young people and for the charity sector. The chair and trustees will need to navigate us through an ever-changing landscape, and my experience on our board and the wider sector will allow me to step up and lead.

It is not just enough to remain steady: we must be ambitious. We must ensure that as we grow we can be visionary in creating a world where young people are empowered to create real social and political change. Having attended events as a trustee over the past four years, I have seen young people go from not speaking in a small group at convention to moving a motion at ACM, this is the BYC impact. Our charity changed my life, and the lives of so many others. It is an honour to be put before you, the members, to ask for your support to lead it

6. Candidates for Trustee

Candidate 1: James Da Costa

I am a strong believer in diversity, digital enablement and the power of young people to affect change through their voices. My background as a British-Indian with roots in Kenya, growing up in Sheffield and studying in the Midlands will complement the diverse profile of the BYC board. As a beneficiary of youth programmes in Sheffield, including the European Youth Parliament and Sheffield BIG Enterprise Challenge, I am passionate about creating these kinds of



opportunities for others across all regions of the UK, and especially for minority communities.

As a trustee, I would bring experience as a management consultant, social entrepreneur and community organizer to the role. Having built a number of education mobile applications, I bring skills in digital, design thinking and content development to the board. For this work I have been recognized as a Diana Award winner and Forbes 30Under30. Becoming a trustee is a natural development opportunity in my own leadership journey, it's a chance for me to provide strategic guidance and apply knowledge from multiple operational roles.

Leading the UK's delegation to the Youth G7 in 2019 gave me an appreciation of key topics on the minds of young people across the UK and a working relationship with many youth organizations. In 2019, from hundreds of interviews with young people, these topics centred around mental health and environmental equity. In 2020, issues surrounding COVID-19 and the economy have been added to the list.

I would bring my full enthusiasm and experience to the role, as well as, new innovative ideas around corporate fundraising, training programmes, and the digital presence of BYC. I am truly committed to the mission and vision of the BYC.

As the Co-Founder of Mandala Group, a 4 year old social enterprise,

Candidate 4: Jack O'Neil

Now more than ever, the British Youth Council (BYC) is integral: as British society rebuilds in a (hopefully) post-COVID world, we need to ensure that young people are not only on the agenda, but are part of the agenda-setting as well.

Growing up in a small and isolated village in Devon, I have battled with disenfranchisement and ageism, and it wasn't until my university years that I fully felt empowered to change the world around me. That is just one of the reasons that I hold organisations such as the BYC close to my heart, and I now believe that I have the skills and experience to contribute to such an organisation.



I believe that trusteeship is about assurance and enhancement: is the organisation in a sustainable position? Is the organisation meeting its charitable objectives? But more than that, what strategic ambitions can be explored? Are there further opportunities to elevate the organisation's publicity, or positive impact for members? I have been active in youth voice and volunteering since the age of 15, when I represented my school's Amnesty International society at national conferences, and joined



a Military Families Youth Forum. I've spent two years as Senior Communications Officer and Youth Voice lead at the #iwill campaign – 1000+ organisations working together to champion youth social action. I'm lucky to work closely with highly motivated young Ambassadors and organisations partnering with young people to lead change. I deeply value the insight these relationships have provided and the networks I have built across the UK.

I have a detailed understanding of where young people wish to see change, how our ambitions can be made real, and the challenges that remain in the path to genuine youth participation. I would also bring a host of relevant experiences to BYC board. I have led campaigns, run youth engagement projects, chaired strategic meetings, worked with the media, and met with party leaders and government ministers. I am a clear-sighted and eloquent advocate for the rights of young people. For an organisation to best serve the participation and empowerment of young people, it requires a structure based on justice, inclusion, and compassion for the realities of young people's lives.

As a member of the Havering Youth Council, I have gone from originally developing independently, to recently breaking through traditional institutions, such as the metropolitan police, and budging through tangible change. Ultimately, it would be my dream to be able to advocate for a political system that is fair and in which all people can thrive. My activism comes from a unique position, as I have been stuck in a cycle of inequality. With English as my alternate language, coming from a low-income family with a father needing my constant medical care, I was responsible for keeping our family afloat as the family advocate. This exposure and battle allows me to genuinely have a strong relationship with the world.

Understanding BYC back-to-front and with this ability to care responsibly, I have achieved ground-breaking advances as MYP. Being one of the youngest people to draft a bill, the Youth Violence Commission; facilitating BBC Debates for young people to have a voice; organising protests during the knife-crime epidemic. I live youth voice.

Injustices are strong and no two campaigners' fights are the same. An ideal trustee would take this into careful consideration when making even the slightest decisions. I strongly believe that with kindness and humanity, change will be made.



9. Honorary Presidents Election

Each year three MPs, one from each of the largest three parties in the House of Commons, are elected to this position. They champion the British Youth Council's work in Parliament and work with us to ensure that youth voice is at the top of the agenda for decision makers and across the Government. Each of the Honorary Presidents also acts as a champion for youth voice within their own political party.

In the past, Honorary Presidents have asked the Government questions on the British Youth Council's behalf, have helped us with the hosting of events and have supported us in a variety of other ways.

In the event that 'RON' is elected for any of the Honorary President positions, the decision of who shall fill the vacancy passes to the Board of Trustees. When required to decide upon an Honorary President, the Trustees shall take into account the views expressed by the membership, and candidates who featured in the original election shall be excluded from consideration. The decision of the Board of Trustees is final.

10. UK Young Ambassador – European Youth Forum

The UK Young Ambassadors enable young people from across the UK to have a voice and influence in international decision-making and to campaign for change on local, national and international levels. The UK Young Ambassador programme is open to any young person (18-25) from across the UK (England, Northern Ireland, Scotland and Wales). The programme is divided into three main strands:

- Two UK Young Ambassadors representing the British Youth Council and our members in the Commonwealth Youth Forum;
- Two UK Young Ambassadors representing the British Youth Council and our members in the European Youth Forum:
- Four UK Young Ambassadors (one from each of the nations in the UK) leading our work on the EU Youth Dialogue.

The UK Young Ambassadors for the European Youth Forum and the Commonwealth Youth Forum are elected by our member organisations, while the UK Young Ambassadors for the EU Youth Dialogue are selected.

At the Annual Council Meeting we will be electing one female or non-binary UK Young Ambassador to the European Youth Forum. Our intention is to have a gender-balanced delegation, which is why we have only opened this call to young people who identify as female or non-binary. The term of office for the new UK Young Ambassador will be 3 years.

Role of a UK Young Ambassador to the European Youth Forum

- Inform and influence European policy making through attending the European Youth Forum Council of Members Meetings (COMEM) as well as representing the British Youth Council at sub-regional meetings;
- Get involved in research and consultation with young people across the UK to gather their views, including workshops, focus groups and online research, whenever appropriate;
- Design and deliver advocacy actions, responding to UK young people's needs and concerns arising from the European Youth Forum;
- Share information from the European Youth Forum with the Member Organisations of the British Youth Council and with young people across the UK;
- Ensure the most current and pressing issues for young people in the UK are translated in European youth policy making;
- Liaise with the wider team of UK Young Ambassadors to align work and priorities and assist the rest of the team on relevant campaigns and advocacy on local, national and European levels;
- Raise awareness of European campaigns, policies and actions through reports, blogs, websites and social networks;
- Represent UK young people at European events and to UK decision makers;
- Provide policy feedback to the British Youth Council, member organisations and youth and networks;
- Be an active part of a European network, share information, ideas and actions.

The newly elected UK Young Ambassador will be working alongside the existing UK Young Ambassador to the European Youth Forum Tom Matthews. Tom is from North Devon. He studies Geography, Politics and Sociology at Exeter College where he is a Student Governor. He is the Secretary General of Exeter College Model United Nations and used to be the Member of Youth Parliament for Torridge, North Devon and West Devon.





Candidate 1: Sylvia Cullen

Youth organisations have changed my life. From BYC related opportunities to creative projects through Opera North and the WY Play-house, I have been fortunate with the opportunities that have come my way as a result of Youth Organisations. Last year, I worked in a primary school in Chapel town and saw the way in which Youth Organisations not only change lives, but save them. From anti-gang projects to sport groups that helped children to



channel themselves in a positive way, Youth Organisations are undoubtedly one of the greatest tools we have to help young people achieve to their greatest potential. The work of the EU Youth Forum seems to me a great chance to 'give back' in a sense, for the way in which Youth services have benefitted me, by working on an international scale in favour of Youth Services and strengthening Youth Participation wherever possible.

Personally, I am driven by a comment made by an official who said that I was 'unlikely to achieve much' because my Dad was in prison. This injustice gave me the drive to work as hard as I can to prove that personal circumstances are not a barrier to success- it's what you do that counts. I have learnt to be pragmatic, resourceful and never wait for somebody else to 'do it for me' because I was propelled into a situation which forced me to stand on my own two feet. I hope that this skill set would make me an asset to the European Youth Forum.

In starting my own company to improve social care of vulnerable people, lobbying my university to improve its racism reporting, representing youth voices on Brexit to Hillary Clinton, and pushing global companies to let more women into the work place, I've thrown myself into being a voice for the voiceless at home in the UK.

In the rest of Europe, I'm fighting corporations and working with governments to provide resources for refugees and disenfranchised young people. I make sure that while caring about young people, I also care about what matters to them. In work, I'm building on my Environmental Leadership award to help engineer clean cars in our generation's fight for a greener planet. Through EU policy and advocacy, I am helping young people recover financially and with their mental health from Covid-19. Whatever the issue, whoever the young person, I'm here to listen and learn.

11. UK Young Ambassador – Commonwealth Youth Council

At the Annual Council Meeting we will be electing one female or non-binary UK Young Ambassador to the Commonwealth Youth Council. Our intention is to have a gender-balanced delegation, which is why we have only opened this call to young people who identify as female or non-binary. The term of office for the new UK Young Ambassador will be three years.

Role of a UK Young Ambassador to the Commonwealth Youth Council

- Represent BYC and UK young people at Commonwealth forums and events
- Carry out UK policy research with BYC and through our memberships and networks
- Be accountable to BYC members and young people in the UK, through regular communications and reporting
- Inform and influence Commonwealth decision-making on BYC campaigns and issues of interest and concern to young people in the UK
- Advocate with and for young people on Commonwealth-wide issues, including on international development and the post-2015
- Help promote and engage young people in Commonwealth campaigns, projects and activities
- Support more young people to get involved in UKYA, including as researchers, advocates, campaigners, and bloggers
- Promote your work, the work of the Commonwealth Youth Council and the work of UKYA
- Be an active member of the UK Young Ambassadors team
- Participate in BYC events
- Participate in BYC and UKYA meetings
- Represent the interests of young people in the UK, and not any other interests, including that of a political party.

The newly elected UK Young Ambassador will be working alongside the existing UK Young Ambassador to the Commonwealth Youth Council Namir Chowdhury. Namir has worked on a multitude of social issues, including racial discrimination and mental health provisions. He has created and facilitated workshops addressing mental health in institutions across the UK in an effort to normalise conversations around the topic. His work culminated in speaking at the House of Commons, where he called for better mental health services to



be available in the form of school counsellors. He has operated in numerous roles with the British Youth Council, including as the UK's Young Ambassador to the Commonwealth, through which he attended CYF 2018. Subsequently, he focussed on raising awareness of the Commonwealth among young people within the UK by leading educational sessions with schools and youth organisations.



Candidate 1: Elif Emma

I am a passionate campaigner from the North East, with previous experience working with the British Youth Council and the Commonwealth. As a second generation Turkish immigrant, I understand the challenges of being a minority in monocultural spaces. In my experience, international opportunities have always been reserved for the privileged. If I were to occupy this role, I would represent disadvantaged young people within the Commonwealth and empower their voices in a beautiful, diverse international community.



Growing up in South Tyneside, I was witness to the impacts of poverty in my school and in my community. My frustration fuelled my desire to campaign in a local, youth led group that aimed to raise awareness about local poverty conditions. We presented our manifesto to parliament and were heard in a space where we had felt unacknowledged. Since then, I have furthered my advocacy by working with organisations such as Barnardo's, Barclay's Lifeskills and Sustain to tackle the employment and health aspects of poverty.

In 2018, I successfully secured a two year scholarship to research how discourse impacts lived experiences of poverty. I presented my research findings at the 6th International Conference on Poverty and Sustainable Development in Sri Lanka. Learning more about experiences in Commonwealth countries, such as Sri Lanka, India and Pakistan, was extremely formative to developing my understanding of Commonwealth issues.

I am aware of other issues that desperately need to be addressed in the Commonwealth. In my contribution to bringing about change for people in poverty, it is impossible to ignore the intersectional issues such as racism, LGBTQ+ rights and gender discrimination that heavily intersect with poverty. I am eager to address these issues within the Commonwealth, while representing the values of the British Youth Council by uplifting young people's voices.
